

Competition Terms and Conditions

Competition Schedule — September 2026 Cycle

PART A

1. Competition Name: Prize Hub Rewards Club Monthly Mega Draw and Weekly Member Draws.
2. Promoter: Prize Hub Rewards Club Pty Ltd (ACN 696 955 290) (Promoter) of 14 The Strand, Colonel Light Gardens, South Australia 5041 (Head Office). Contact details available at: www.prizehubrc.com (Website).
3. Entry Requirements: Entrants must be at least 18 years of age, must reside in the Territory and must purchase a membership package via the Promoter's website located at www.prizehubrc.com, which gives the purchaser access to special discounts and invitations to VIP events (Membership Package). The Entrant will receive a number of entries in the Competition as set out on the Membership Packages page, depending on the Membership Package purchased. The Entrant may also receive Loyalty Bonus Entries and Founding Member Multiplier entries, as set out in the Membership Terms. The Entrant should hold a valid, unsuspended Membership Package during the Competition Period. Entries may also be obtained by purchasing specific merchandise on the Promoter's Website, the number of entries received will be as set out therein. All Entrants agree and acknowledge that if their Membership Package has been suspended by the Promoter for any reason, including but not limited to non-payment of the Membership Package payment fee, then new entries shall not accrue to such Entrant.
4. Maximum entries: 10,000 per person. Entries shall be calculated in accordance with the following formula: Total Entries = ((Base Entries + Loyalty Bonus Entries) x Founding Member Multiplier) + Referral Bonus Entries + Anniversary Bonus Entries. If an Entrant's calculated entries exceed the maximum number of entries, the Entrant's entries will be capped at 10,000 for that draw. For the purposes of this clause: (a) Base Entries means the standard number of entries allocated to an Entrant's Membership Package; (b) Loyalty Bonus Entries means any additional entries earned from Month 3 of continuous, unbroken membership; (c) Founding Member Multiplier means the 2x multiplier applied to Base Entries and Loyalty Bonus Entries for eligible Founding Members; and (d) Referral Bonus Entries means entries awarded for eligible referrals. For the avoidance of doubt, Referral Bonus Entries are not doubled by the Founding Member Multiplier. If an Entrant cancels, allows their Membership Package to lapse, or has their Membership Package terminated, all accumulated Loyalty Bonus Entries and Founding Member status may be permanently lost in accordance with the Membership Terms.
5. Number of winners: There will be a maximum number of winners, per below: (a) Weekly Draws: i. Bronze: 1 per week; ii. Silver: 1 per week; iii. Gold and Platinum: 1 per week. For the avoidance of doubt, there will be 1 winner drawn from the combined pool of Gold and Platinum members. (b) Mega Draw: 1 winner per month
6. Territories: Australia-wide, excluding South Australia.
7. Competition Period: Competition commences 12:00am on 1 September 2026 and ends at 5:00pm on 30 September 2026. Multiple draws will occur under this trade promotion. The final draw will be drawn at 6:00pm on 30 September 2026, with the winner notified by 7 October 2026. The multiple draws are as follows: (a) Weekly prize draws for the Bronze, Silver, Gold and Platinum tiers of the Membership Packages, which shall occur on a weekly basis, as set out in Annexure A (Weekly Draws). For the avoidance of doubt, one Winner will be selected for each Bronze Weekly Draw and each Silver Weekly Draw. One Winner will also be selected from the combined Gold and Platinum pool for each Gold and Platinum Weekly Draw. There are no Weekly Draws for the Copper tier; and (b) The monthly draw which shall open at 12:00am on 1 September 2026 and end at 5:00pm on 30 September 2026 (Monthly Mega Draw). The Monthly Draw shall be drawn at 6:00pm on 30 September 2026. Considering that the Major Prize will be drawn last in the promotion, all eligible entries, irrespective of any prior draws, will remain eligible for a monthly draw at 6:00pm on 30 September 2026. For the avoidance of doubt, subject to the Entry Requirements and these Terms and Conditions, eligible entries held by Copper tier members are eligible to be entered into the Monthly Mega Draw.

8. Prizes:

(a) **Mega Draw:** The prize for the Monthly Mega Draw shall be one 20-gram gold bar valued at approximately \$5,000 or a cash alternative of \$3,000, at the election of the Winner of the Monthly Mega Draw. (For the avoidance of doubt, if the Winner chooses the Gold Bar, they will not receive the Cash Prize, and vice versa.)

(b) **Weekly Draws:** The prize for each Weekly Draw will be a product, voucher, or combination of products and/or vouchers sourced from one or more of the Promoter's partner businesses, up to the maximum value set out in Annexure A for that tier (Weekly Prize). The exact composition of each Weekly Prize will be determined by the Promoter in its sole discretion prior to each draw and may vary from week to week. The Weekly Prize mechanic is intended to showcase and promote the Promoter's partner businesses to the Promoter's membership.

For the purposes of this Competition, the total prize pool is estimated to be no more than \$8,000.00. The Prize(s) must be taken as stated and are not transferable to another person, unless agreed to in writing by the Promoter. The Prizes are not exchangeable for other goods or services from the Promoter. Any additional expense incurred as a result of winning this prize is the responsibility of the Winner. The Promoter reserves the right to substitute the Prizes with an equivalent cash prize in its sole discretion.

9. **Prize date and selection of winners:** All entries will be assigned a number, and the Winners will be drawn by RandomDraws.com, or another random electronic number generator. The Monthly Mega Draw will be drawn at 6:00pm on 30 September 2026 at the Head Office. The Weekly Draws will be drawn on the dates and times as set out in Annexure A at the Head Office. For the avoidance of doubt, an Entrant's entries into a Weekly Draw will be based on their eligible Membership Package tier and total valid entries at the time entries close for that Weekly Draw. Bronze members will only be entered into the Bronze Weekly Draw, Silver members will only be entered into the Silver Weekly Draw, and Gold and Platinum members will only be entered into the combined Gold and Platinum Weekly Draw.

10. **Publication of winners:** Winners will be personally notified by email and phone call within 7 days of the draw. Winners will also be announced online at the Promoter's Website and social media within 7 days of the draw, and will remain published for a minimum period of twenty-eight (28) days.

11. **Winner eligibility:** To be eligible to win, the Entrant's details provided to us must contain correct and accurate information. Employees of the Promoter and immediate family members of employees of the Promoter are not eligible to win.

12. **Prize Delivery:** Prizes will be delivered to the Winners to their nominated address or email address (at the Promoter's discretion) within twenty-eight (28) business days of the Draw / re-draw date. If the Prize contains a cash prize, it will be delivered to the Winner by bank transfer to their nominated bank account. The Promoter will pay for the delivery of the Prize to the Winner's nominated address. However, the Winner is responsible for any other costs associated with its receipt of the Prize, including any taxes or transfer duties or costs.

13. **Force Majeure:** The Promoter shall not be liable for any failure or delay in delivering the Prize within the specified timeframe due to circumstances beyond its reasonable control, including but not limited to acts of God, natural disasters, pandemics, government restrictions, industrial disputes, supply chain disruptions, transportation delays, or any failure or delay caused by the Prize Supplier(s) ("Force Majeure Event"). In the event of a Force Majeure Event, the Promoter will use all reasonable efforts to arrange for the delivery of the Prize as soon as practicable. The winner will be notified of any expected delays and, where possible, offered an alternative prize of equal or greater value, subject to availability and at the Promoter's sole discretion.

PART B

1. Information on how to enter and information provided in Part A form part of these Terms and Conditions and by entering into this Competition, each Entrant is deemed to have accepted and understood these Terms and Conditions. The Entrant agrees that these Terms and Conditions constitute all of the Terms and Conditions between the Entrant and the Promoter governing this Competition.

Participation

2. To enter, Entrants must meet all of the Entry Requirements to enter the Competition as set out in the Schedule. The Entrant warrants and represents to the Promoter that it meets all of the Entry Requirements.
3. Entry is open to residents of the Territories.
4. The Competition will be open during the Competition Period. All eligible entries must be received by the Promoter during this time. Entries are deemed to be received at the time of receipt by the Promoter and not at the time of transmission by the Entrant.

Selection of Winner

5. The Winner will be selected by random draw, on the dates and at the location outlined in Part A. Entries that are incomplete or incomprehensible will be deemed invalid and will be ineligible to win.
6. Prizes will only be awarded to the person named on entry, subject to their entry complying with these Terms and Conditions.
7. Subject to clause 8 of Part B, if a Winner is selected but passes away before claiming the prize (or part of it), the prize will be awarded to the Winner's estate, provided a certified copy of the Winner's death certificate is supplied within one (1) week of the Draw Date.
8. If for any reason, a prize or element of a prize is unclaimed by the Winner or its estate within 3 months of the final Draw Date despite reasonable steps by the Promoter to contact the Winner, the Monthly Mega Draw will be re-drawn at 6:00pm on 30 December 2026 and the Weekly Draws will be re-drawn on the dates and at the times as set out in the Annexures. The Winners of the re-draw will be drawn by a random electronic number generator (for example, randomdraws.com.au) accessed on a device at the Head Office.
9. The Winner of the re-drawn prize will be: (a) notified by email within 7 days of the re-draw; (b) announced online at the Promoter's Website within 7 days of the re-draw; and (c) published on the Promoter's social media accounts within 30 days of the re-draw.
10. The Entrant is solely responsible for ensuring that it is eligible to be a Winner, and the Promoter will not be in any way liable to an Entrant, should the Entrant be found to be ineligible to win the Competition.

Prizes

11. Prizes are provided on an "as is" basis and the Promoter will not make any modifications to the Prizes at the Winner's request.
12. The Promoter will not be liable for any delivery of prizes to a wrong address or account due to any error by the Winner.
13. If the Winner claims a prize but is found to be ineligible or if the Winner does not provide valid delivery details within the time frame specified by the Promoter, the Winner forfeits the Prize and it will not be re-drawn.
14. The Promoter will not be liable for re-drawing or providing a replacement prize for any Prizes that are not received by the Winner due to being lost in transit, stolen or due to any failure to accept delivery by the Winner or due to any error in details provided by the Winner.
15. The Prizes may contain goods or services from 3rd party brands. Unless otherwise specified, the provision, advertisement or offer of prizes from a 3rd party brand does not constitute any sponsorship, approval or endorsement of the good, service, content, policies, practices or services offered by those parties.
16. Where a Prize is specified to be delivered directly from the 3rd party prize supplier, as a condition of entry, the Winner agrees that its details may be provided to the 3rd party prize supplier by the Promoter on its behalf for the purpose of delivery of the Prize to the Winner.

17. The Monthly Mega Draw Prize offered under this Promotion is gold. The Winner acknowledges and accepts that the value of gold varies depending on the current market and the value stated in clause 8 of Part A is the value of the gold as at the date of these Terms and Conditions.

Personal information

18. As a condition of entering this Competition, Entrants agree to provide personal information to the Promoter. Personal information collected during the course of this Competition will be dealt with in accordance with the Promoter's Privacy Policy, located at the Promoter's Website. Personal information submitted may be provided to third parties for the purpose of administering this Competition and distributing the prizes, including to agents, contractors and prize suppliers. The Promoter may also use this personal information to contact you regarding marketing, offers or Competitions from time to time.

19. As a condition of entry, each Entrant agrees that if they are selected as a Winner, the Promoter may use, record, film, photograph, livestream, broadcast, publish, repost and otherwise publicise the Winner's name, likeness, voice, image, photograph, video footage, social media handle, suburb, state or territory and any statements made by the Winner in connection with the Competition, the Prize, the draw, the Promoter or the Promoter's goods and services. This use may occur on the Promoter's Website, social media pages, email marketing, advertising, promotional materials and any other media worldwide, for an unlimited period of time, without further notice, payment or compensation to the Winner, except where prohibited by law.

Intellectual property

20. By uploading, publishing, transmitting or making available any data, content or other material in connection with this Competition (Entrant Content), the Entrant agrees to grant the Promoter, its affiliates, licensees and successors a nonexclusive, royalty-free, perpetual, irrevocable, worldwide and fully sub-licensable right to use, communicate, reproduce, modify, adapt, publish, publicly perform, translate, create derivative works from, distribute and display in any form, any such content, including but not limited to text, images, videos, graphics, audio and photographs without attribution.

21. The Entrant warrants and represents that: (a) it holds all the intellectual property rights to the Entrant Content; (b) it has the authority and licence to upload, make available and licence the Entrant Content to the Promoter; and (c) the Promoter's use of the content will not infringe or violate any third-party rights, including but not limited to defamation, intellectual property rights, moral rights and privacy rights and will not give rise to an obligation to make any payment to a third party.

22. The Entrant agrees that they are solely liable for the Entrant Content and that, to the fullest extent of the law, the Promoter shall not be liable in any way for such Entrant Content.

Reservation of rights

23. The Promoter reserves the right to request each winner to provide proof of identity or proof of residency at the address specified in their submission in order to claim a prize. Proof of identification and residency is at the absolute discretion of the Promoter. In the event that a Winner cannot provide suitable proof, the Winner will forfeit the prize and no substitute will be offered.

24. The Promoter may, in its absolute discretion, modify, suspend, cancel, void, re-run or redraw the Competition and may administer this Competition in the manner that it considers appropriate in accordance with Australian law, including where the Competition is not capable of running as planned, such as where there has been infection by computer virus, bugs, tampering, unauthorised intervention, fraud, technical failures, platform errors, software errors, entry count discrepancies, electronic or human error, or any other causes beyond the control of the Promoter which corrupt or affect the administration security, fairness, integrity or proper conduct of the Competition.

25. The Promoter reserves the right in its sole discretion to disqualify any Entrant that has, or is suspected by the Promoter to have: (a) breached any of these Terms and Conditions; (b) tampered with the entry process or the

Competition; (c) engaged in any unlawful conduct; (d) engaged in any other improper misconduct calculated to jeopardise the fair and proper conduct of the Competition or the reputation of the Promoter.

Social Media Platforms

26. The Competition may be promoted, livestreamed, broadcast, published or otherwise publicised on social media platforms including but not limited to Facebook, Instagram and its related mobile applications, or other social media platform used by the Promoter (Social Media Platform(s)).
27. The Competition is in no way sponsored, endorsed or administered by, or associated with any Social Media Platforms.
28. The Entrant agrees that it releases the Social Media Platforms from any and all liability to the Entrant arising out of or in connection with the Competition.
29. The Entrant must not: (a) harass or bully any other person, use offensive language, use language that defames the Promoter, or use language that negatively impacts or intends to negatively impact the reputation of the Promoter; or (b) use electronic programs, bots or similar technology to automatically submit entries, and the Promoter reserves the right to disqualify any Entrant or Entry that breaches these terms and remove any such entries from the Competition.

Exclusion of liability

30. The Promoter will not be liable for any late, lost or misdirected entries including due to technical disruptions, delayed or misplaced postage, network congestion or for any other reason. To the maximum extent permitted by law, the Promoter will not accept any liability for any error, omission or failure to administer this Competition.
31. Except for any liability that cannot be excluded by law, all Entrants release, and indemnify and hold harmless the Promoter (including its officers, employees, agents and contractors), from and against, all liability (including negligence), actions, claims, costs, losses or expenses arising out of or in connection with: any act, omission, negligence, fraud, wilful misconduct or breach of these Terms and Conditions by the Entrant, its nominees or agents and the Entrant or Winner's acceptance of, use of or attempted use of any prize(s) and participation in the Competition, including (but not limited to) loss of income, damage to property and personal injury whether direct or consequential, foreseeable, due to some negligent act or omission or otherwise.
32. Except for any liability that cannot be excluded by law, the Promoter (including its officers, employees, agents and contractors) excludes all liability (including negligence), for any personal injury, or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the Competition, including, but not limited to, where arising out of the following: (a) inaccurate or incorrect transcription of entry information; (b) any technical difficulties or equipment malfunction, malfunction of any telephone network or lines, computer online systems or network, servers or providers, computer equipment, or software (whether or not under Promoter's control); (c) the unavailability or inaccessibility of any service whether or not caused by traffic congestion on the Internet or at any website; (d) any theft, unauthorised access or third party interference; (e) electronic or human error which may occur in the administration of the Competition; (f) any variation in prize value as stated in the Schedule; (g) any tax liability incurred by a Winner or Entrant; (h) redemption or use of a prize; and (i) any act or omission, deliberate or negligent, by the Promoter, or its employees or agents, in connection with the arrangement for supply, or the supply, of any goods or services by any person to a Winner and, where applicable, to any family/persons accompanying a Winner.
33. To the maximum extent permitted by law, the Promoter's total aggregate liability to the Entrant under or in any way connected with these Terms and Conditions and the Competition, or the performance or non-performance of these Terms and Conditions is limited to an amount equal to any amounts paid by the Entrant to the Promoter in the three (3) month period immediately preceding the date on which the relevant claim arose, which may be zero.

Draw System Integrity

34. Where the Promoter reasonably determines that any technical, administrative, electronic, platform, software, data processing or system error has occurred in connection with the Competition, including any error or discrepancy caused by or arising from RandomDraws.com, MemberPress, the Promoter's Website, the Promoter's membership

platform, payment processor, entry allocation system, database, random draw system or any other system used to administer entries or conduct a draw, the Promoter may take any action it considers reasonably necessary to preserve the fairness, integrity and proper conduct of the Competition.

35. Without limiting clause 34, the Promoter may, in its discretion and to the maximum extent permitted by law: (a) correct, reconcile, audit or adjust any entry records or entry counts; (b) invalidate, remove or reinstate any affected entries; (c) delay, suspend, void or re-run any affected draw; (d) conduct a redraw for the affected prize or prizes; (e) verify the eligibility of any Entrant or Winner; and/or (f) take any other step reasonably necessary to ensure that the Competition is conducted fairly and in accordance with these Terms and Conditions.

36. If a draw system error, entry count discrepancy or other technical or administrative error affects, or may have affected, the outcome of a draw, the Entrant acknowledges and agrees that, except for any liability that cannot be excluded by law, the Entrant's sole remedy is limited to the Promoter correcting the error, adjusting the relevant entries, re-running the affected draw or conducting a redraw. The Promoter will not be liable to any Entrant or Winner for any financial compensation, loss of opportunity, loss of chance, loss of profit, disappointment, inconvenience or other loss or damage arising from or in connection with any such error, discrepancy, correction, redraw or re-run of a draw.

37. For the avoidance of doubt, where a redraw or re-run of a draw is conducted under this clause, the Promoter's liability is limited to awarding the relevant prize to the validly selected Winner of the corrected draw or redraw, subject to these Terms and Conditions and any applicable law.

General

38. These Terms and Conditions are governed by and will be construed under the laws of South Australia and the parties agree to submit to the exclusive jurisdiction of the courts of South Australia and its appellate courts.

39. Failure by Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.

40. Capitalised terms used throughout these Terms and Conditions are defined in the Schedule unless specified otherwise.

41. Force majeure: In this clause, Force Majeure Event means a circumstance beyond the reasonable control of a party and which results in the party being unable to observe or perform on time an obligation under this Agreement, including but not limited to: acts of God, earthquakes, lightning strikes, floods, droughts, storms, tempests, mud/land slides, explosions, fires, pandemic, any natural disaster, acts of war, terrorism, civil commotion, malicious damage, riots and revolution. If by reason of any Force Majeure Event, the Promoter is unable to perform in whole or in part any obligation under this Agreement then: (a) The Promoter will notify the Entrant / Winner of the Force Majeure Event in writing as soon as reasonably practicable; (b) Provided that the Promoter provided such notice, the Promoter is relieved of that obligation under this Agreement to the extent and for the period that it is unable to perform such obligation; (c) The Promoter must provide notice to the Entrant / Winner, and resume its performance of its obligations as soon as it is reasonably able to do so unless otherwise agreed in writing; and (d) The Promoter will not be liable to the Entrant / Winner under this Agreement for failure to perform such obligation to the extent and for the period of non-performance contemplated by this clause.

42. Unless otherwise specified, all times in these Terms and Conditions are Australian Central Standard Time (ACST) or Australian Central Daylight Time (ACDT), as applicable in South Australia.
